As a best-in-class provider of pharma services solutions, our customer is responsible for supporting clinical trials and facilitating commercial manufacturing and packaging. Trial sponsors rely on this company to help manage the clinical trial lifecycle, a crucial part of which is clinical labeling.

Because clinical labeling helps to ensure the safety and wellbeing of clinical trial participants, specialist knowledge, effective communication, and seamless collaboration are critical to the success of labeling projects. One of the key steps involves a technique called core text creation wherein subject matter experts work to create a Master English Label Text (MELT) based on the source material provided by the customer.

The MELT file contains important information gathered from the clinical trial essential documents such as protocol synopsis. Once finalized, it can be adapted to fit different packaging types (e.g. cartons, vials, bottles, syringes) and adhere to

unique regional regulations. Using English as a pivot language, the master text and its different versions can be translated into multiple languages and disseminated to participating regions.

On behalf of their end client, a pharmaceutical trial sponsor, the customer sought core text creation services concerning a lead drug candidate for multiple neuropsychiatric indications including:

- Schizophrenia
- Bipolar Disorder (BD)
- Major Depressive Disorder (MDD)
- Behavioral and Psychotic Symptoms of Dementia or Alzheimer's disease (BPSD)
- Parkinson's Disease Psychosis (PDP)
- Attention Deficit Hyperactivity Disorder (ADHD)

# The Challenge

Initially, the customer tasked Lionbridge with only core text creation; however, they later elected Lionbridge to carry out MELT adaptations and translations as well.

To successfully carry out this project, understanding of the customer's needs and requirements would be the principal concern, followed by adapting the core text and delivering translations for five different countries. Lionbridge helped the customer overcome the following challenges, including the need to:

- Facilitate clear communication and confirm mandatory elements for core text creation
- Uncover and resolve discrepancies within source material
- Adapt core text in accordance with regulatory requirements for each country
- Create and execute translation workflows in a timely manner
